Hello Commissioner Eileen and Former Senator Mike Kowall,

I hope this email finds you both well. My name is Melissa Williams. We spoke about two months ago regarding some concerns I was addressing at the County Commissioners board meeting. I cannot tell you enough how encouraged I was by our conversation.

I am writing today, because many of my concerns addressed in that board meeting are coming to pass at an alarming rate. Since we spoke, two Michigan universities have gone public with their requirements for vaccine passports. This is egregious, considering the vaccines are experimental and do not have FDA approval. They were pushed through for emergency use only. This means clinical trials are being done on the general population from now until 2023. The trial animals that received the vaccine died when reintroduced to the covid virus, and this is evidence enough of the need for extensive research. This has nothing to do with "keeping Michigan safe." There are some scary politics happening.

I attended a rally at the Michigan State Capitol in Lansing this morning for Michigan Vaccine Choice. Currently Michigan is a vaccine choice state. Additionally, no one inside or outside the state of Michigan can require any human being to take an experimental medicine according to Nuremberg Code (Nuremberg Code, via USA vs. Brandt). As of April 28, there have been 86,080 covid vaccine injuries and 3,186 deaths related to the Covid-19 vaccine reported to VAERS.hhs.gov. On a personal level, I have a coworker whose close friend was affected as well. Her baby died at 34 weeks directly after receiving the vaccine. A friend and health care worker reported seeing PET scans and mammograms with serious inflammation (autoimmune response) at a local hospital as a result of the covid vaccine. I could go on and on with more examples but will save that information for a conversation.

Today I learned that our Governor will only reopen the state when vaccination levels have met specific numbers. I include the article here:

How long will it be before my family, (that chooses not to get the vaccine and already has natural immunity), will not be able to go to the grocery store or go to work or renew my driver's license or get medical treatment or travel or go to school or attend university?

Today I'm asking for your help--not just for my own family and our well-being--but thousands of people with whom we are in communications in the state of Michigan that are horrified at what is happening to our civil freedoms. I would like to focus my efforts at the county level, restricting the governor's mandates at the county line. I'm not alone.

I have hundreds of people with me in our county that are ready to address this. We need an advocate.

Would you be willing to help me file a resolution at the County Commissioner's Board to ban vaccine passports and vaccine mandates at the county level? It truly could mean life or death and irreversible damages to a whole generation of young people and community members that never signed up to be an experiment. Vaccines should always be a choice.

Here is an 18 minute video of Human Rights Attorney, Leigh Dundas, from Orange Co. California, fighting similar battles. Newsom and Whitmer are following similar tracks. Dundas was able to stop the process at the county level because of human rights violations: https://youtu.be/bn8JcIGE0b8

I met a woman today from Muskegon, who is working with a County Commission board member and is making great progress with a similar resolution. I have asked her to send me the resolution that she and her commissioners filed in Muskegan County. I will receive it shortly.
