This is Michelle's Stop the Passport Initiative she sent out to her people the day of the vote. I use the same talking points when addressing my county commissioners along with my own personal stories. Notice she focuses on liberties and discrimination and two-tiered society.

- 1. Great example of what you can have your people do the day of the vote, and
- 2. Bullet point list to use when calling in for public comment or writing emails previous to the vote:

FRIENDS, FREEDOM FIGHTERS & ALL WHO DEFEND LIBERTY,

Tomorrow is the day we have been fighting for. Honestly, I have tears in my eyes as I type these words. Most of you I have never met and yet we have banned together to fight a common cause; a cause that is one small step in the greater battle we are waging. A small but **MIGHTY** step.

It was only 7 weeks ago when I was inspired to call into my County Commissioners meeting to ask them to pass a resolution banning the vaccine passport from Muskegon County. I was <u>one</u> voice that day and was <u>ignored</u>. Today, we are an **ARMY** of everyday people, the **GRASSROOTS** of our nation, and we have accomplished so much more than I could have imagined when I made that first phone call. With the help of some **PATRIOTIC WARRIOR** commissioners who heard my plea, the resolution was brought before the Commissioners on 4/13 only to be defeated in a vote of 5-4. The supporters that had gathered at that time took it as a good thing; we only had to get <u>ONE MORE COMMISSIONER</u> to vote for the resolution and after working together and continuing to apply public pressure by emailing and calling into the meetings, the resolution was reintroduced and passed out of the Health and Human Services Committee having **FLIPPED THE VOTE OF ONE OF THE COMMISSIONERS!** 

### TOMORROW IS OUR DAY!

Tomorrow is the day we find out if the resolution passes. The day we find out if the first of many counties in the state of Michigan adopts this or a similar resolution. The day we find out if this resolution is sent to the House of Representatives, the Senate, and to our Governor, Gretchen Whitmer, to tell them **ALL** where **WE THE PEOPLE** stand on vaccine passports in our beautiful state.

To that end: **WE NEED YOUR VOICE TO BE HEARD** at the Board of Commissioners meeting **TOMORROW**, **TUESDAY MAY 11TH AT 4** 

**PM.** Last week <u>THIS</u> article came out in response to our win (of course it completely misrepresents what was said) and it may attract more opposition that we have had in the past. **PLEASE CALL IN**. Get your mother, brother, sister, cousin, high school

friend... anyone you know who opposes vaccine passports to take that step of action and call in!!

THE MEETING IS ON THE AGENDA SO WE WILL BE SPEAKING DURING THE FIRST PUBLIC COMMENT TIME.... ITEM 8 ON THE AGENDA.

## THIS IS OUR OPPORTUNITY TO MAKE THE CASE TO VOTE FOR THE RESOLUTION!!

Here are some important talking points. I encourage you to write your thoughts down prior to your turn to speak:

- Do not make this about the vaccine. Many of the Commissioners are vaccinated AS IS THEIR RIGHT. This call is to urge them to PASS THE RESOLUTION regarding VACCINE PASSPORTS.
- Remember to specifically ask them to <u>PASS THE RESOLUTION</u>
- Then give them the reasons why this is important for the people of Muskegon.
- Vaccine passports are discriminatory.
- The discrimination that will result based on vaccine status will know no bounds; it will effect all races, genders, sexual orientations, religions & political affiliations.
- At a time when our leaders are calling for unity, we need our Commissioners to pass this resolution to protect our community from the deep segregation that will result from businesses, schools &/or government entities requiring proof of vaccine status.
- The ACLU (American Civil Liberties Union) have spoken out against Vaccine Passports.
- The resolution helps to protect EVERYONE'S rights to MEDICAL PRIVACY & BODILY AUTONOMY.
- By passing this resolution, the Commissioners are sending a message to the people of Muskegon that they value the tight knit community we all share. That they reject the segregation that will occur if vaccine passports are to be implemented in our county.
- Feel free to use Israel as an example and use concrete events that have happened there.... bring it back to the fact that we do not want these things happening in Muskegon County and we are sure the Commissioners do not as well.
- Feel free to use what happened in St. Vincents (people could not evacuate from an active volcano eruption unless they were vaxed first).

- Vaccine Passports give special privileges to those who are able to get the vaccine by allowing them to access public spaces where those who are not vaccinated are banned. It is DISCRIMINATORY to those who are unable to receive the vaccine, those who are hesitant based on the experimental status and would like to wait for more data, and those who choose not to vaccinate.
- Passing this resolution helps to protect OUR MEDICAL PRIVACY AND BODILY AUTONOMY.
- Passing this resolution is not anti-vaccine, it is pro MEDICAL FREEDOM, pro MEDICAL PRIVACY, & pro BODILY AUTONOMY.

(and if you have called in before, feel free to use your thoughts again... I have been consistently *BLOWN AWAY* by the thoughtful, informed, well spoken speeches I have heard. Seriously, this group is intelligent and articulate and IMPRESSIVE!)

### WHAT TO DO:

**HERE** is the link to the agenda and everything you need to know to call in. (sidenote: I do not use zoom, I call in and let the meeting play in the background until it is time to speak)

- At 4 pm call into the meeting using zoom or just the phone number
- The Commissioners will work their way down the agenda
- At item number 8) Public Comment (on an agenda item), raise your hand and speak when called upon. **THIS IS OUR TIME TO SHINE!** You have 2 minutes.
- The next items on the agenda are the Committee/Board reports <u>and the vote for the resolution will come under 9b...</u> the report from the Health & Human <u>Services Committee.</u>
- IF THEY PASS THE RESOLUTION: Stay on the call and **THANK THE BOARD FOR PASSING THE RESOLUTION**
- IF THEY DO NOT PASS THE RESOLUTION: Stay on the call and ASK THEM TO RECONSIDER (But they will pass it... stay positive!!!!!!!)

### WHEN IT IS YOUR TURN TO SPEAK:

- State your Name and then give your comments. If they ask you to state where you live, give your TOWNSHIP
- If you live in Muskegon, talk about how life here will change. Give specific places and situations.

• If you do not live in Muskegon, THAT IS 100% OK. You still have the right to call in and say that you want the resolution to be passed. If you visit, work, camp, go to the beach, etc in Muskegon mention that... but it is not required. Just make your case of why banning a vaccine passport is important.
