3. Be ready to SHOW UP ON CALL by dialing in to the committee meetings and read a short prepared statement. I will actually provide strategic talking points that were well developed in Muskegon that worked. The tentative date for the committee meeting is this Tuesday:

COMMITTEE MEETING:

LAGO is the Legislative Affairs & Government Operations Committee. The next meeting is this Tuesday morning at 9:30. There will be public comment period, of course. I don't know if Vaccine Passport Resolution will be on this agenda or if it will be on the next one. BUT WE SHOW UP ANYWAY!!

If for some reason this number changes I will let you know.

When you dial that number you will be greeted by the administrative staff. They will take your name and ask if you'd like to make public comment. When it's time for public comment they will call your name and you can simply read your statement. Keep it simple, highlight one focus why you want to see vaccine passports bannned, finish by telling them you want them to PASS THE RESOLUTION. keep it under 3 minutes.

Here are strategic talking points:

THIS IS OUR OPPORTUNITY TO MAKE THE CASE TO VOTE FOR THE RESOLUTION!!

 $\cdot\,$ Do not make this about the vaccine. Many of the Commissioners are vaccinated AS IS THEIR RIGHT. This call is to urge them to PASS THE RESOLUTION regarding VACCINE PASSPORTS.

· Remember to specifically ask them to PASS THE RESOLUTION

 \cdot Then give them the reasons why this is important for the people of Oakland County.

· Vaccine passports are discriminatory.

• The discrimination that will result based on vaccine status will know no bounds; it will effect all races, genders, sexual orientations, religions & political affiliations.

 \cdot At a time when our leaders are calling for unity, we need our Commissioners to pass this resolution to protect our community from the deep segregation that will result from businesses, schools &/or government entities requiring proof of vaccine status.

• The ACLU (American Civil Liberties Union) have spoken out against Vaccine Passports.

• The resolution helps to protect EVERYONE'S rights to MEDICAL PRIVACY & BODILY AUTONOMY.

 \cdot By passing this resolution, the Commissioners are sending a message to the people of Oakland County that they value the tight knit community we all share. That they reject the segregation that will occur if vaccine passports are to be implemented in our county.

 \cdot Feel free to use Israel as an example and use concrete events that have happened there.... bring it back to the fact that we do not want these things happening in Oakland County and we are sure the Commissioners do not as well.

 \cdot Feel free to use what happened in St. Vincents (people could not evacuate from an active volcano eruption unless they were vaxed first).

 \cdot Vaccine Passports give special privileges to those who are able to get the vaccine by allowing them to access public spaces where those who are not vaccinated are banned. It is DISCRIMINATORY to those who are unable to receive the vaccine, those who are hesitant based on the experimental status and would like to wait for more data, and those who choose not to vaccinate.

· Passing this resolution helps to protect OUR MEDICAL PRIVACY AND BODILY AUTONOMY.

 $\cdot\,$ Passing this resolution is not anti-vaccine, it is pro MEDICAL FREEDOM, pro MEDICAL PRIVACY, & pro BODILY AUTONOMY.

Pass this on to everybody in your sphere of influence that you know feels the same way about vaccine passports in our County. Inspire them by telling them Muskegon got it done with a grassroots group of homeschool moms in a neighborhood, with zero political experience. The only way this was accomplished in Muskegon was that email and call-in warriors rose to the occasion and did their part! The flooding of emails actually turned one vote just because a commissioner couldn't stand all the emails he was receiving.
